- Erika Sugarmon: Elected to the Shelby County Board of Commission in 2022, with 25 years as an educator, Erika Sugarmon leads an illustrious career. Actively engaged in community organizations like WILLOW, TN-WPC, SCDP, and M-SCEA, Sugarmon's extensive civic involvement includes roles on the Youth Village Council, Foster Care Review Board, and TN COVID-19 Health Care Task Force. "Always in the interest of social justice and equity."

#### Panelists:

1. Gwen Turner: A survivor and advocate in the fight to end domestic violence, uses her personal experience of enduring over twenty years of abuse as the foundation of her mission to empower and lead victims to healing. Through her work with organizations like The Family Safety Center, the Crime Victims/Rape Center, and the Shelby County District Attorney's Office, she continues to impact lives and raise awareness. Currently serving as the Shelter Coordinator for YWCA of Greater Memphis, Gwen's faith and resilience drive her efforts to restore hope for others.

3. Tina Fox: A native Memphian and great-granddaughter of a slave, retired in 2019 after 30 years with the Tennessee State Government, including serving as the first African American state Director of Victim Services for the Tennessee Board of Parole. She was nationally recognized in 2018 with the U.S. Department of Justice's National Crime Victims' Rights Award. Tina holds multiple leadership degrees and certifications, and is currently the Director of Community Relations for the Tennessee Coalition to End Domestic and Sexual Violence. Active in numerous organizations, she is also Vice President of TSU's Nashville Alumni Chapter and a member of Schrader Lane Church of Christ, where she co-chairs the Single Sistahs Ministry.

4. R. Romona Jackson: Founding President and CEO of The Women's Advocacy Center, a nonprofit dedicated to empowering and supporting survivors of domestic abuse in Shelby County, Tennessee. Since its founding in 2018, the organization has provided services to hundreds of women and children. Romona, an attorney and retired business professional, is also a best-selling author and an active member of various bar associations and civic organizations. She and her husband Greg care for two children in Nairobi, Kenya. In her downtime, Romona enjoys tennis, reading, walking, and engaging in prayer and spiritual practices, while also speaking on domestic abuse and women's issues.
